Sub: Prayer for lodging First Information Report.

Sir,

In producing herewith the 04 (Four) arrested accused persons namely (i) Chakradhar Mahato (32 Yrs) S/o- Babulal Mahato (ii) Kalipada @ Kaliya Mahato (32 Yrs) S/o- Nipendranath Mahato both of Vill- Kanali, PS- Purulia (M), Dist- Purulia (iii) Jagadish Ch. Roy (42 Yrs) S/o- Lt. Kanka Roy of Vill- Bamro, PS- Purulia (M), Dist- Purulia & (iv) Arjun Mahato (30 Yrs) S/o- Badal Mahato of Vill+PO- Fusro, PS- Chandankeyari, Dist- Bakaro, Jharkhand and brought under seizure (i) Rs- 37,700/- (Thirty Seven Thousand Seven Hundred) of cash (ii) Playing cards 32 pcs (iii) One Charge Bulb (iv) One yellow colored plastic sheet as per enclosed seizure list duly signed by the witnesses as well as arrested accused persons except one accused along with memo of arrest and seizure list.

I beg to state that today (20.09.2024) myself along with force are performing evening night mobile duty at PS area at about 20:45 hrs received a source information that playing of gambling is going on in a shed at Bamro village under Purulia (M) PS. Dist- Purulia where 07/08 persons are playing gambling with the help of money intending to wrongful gain to each other and one Birbhadrab Gorain being the occupier of such shed willfully allowed the said shed for playing gambling. Accordingly, I informed the matter to you and as per your direction myself along with C/- 1494 Manas Mukherjee & C/ 664 Sahebram Saren left for Bamro village area to work out the information. At 21:15 hrs we arrived at Bamro village area. On arrival there as per identification by the source, we entered into a shed and found that some persons were playing cards. Seeing the Police party, the customers, those who were present there left that room and fled away, however we could not detain all persons in that room but we successfully detained 04 (Four) persons. On being asked the detained persons disclosed their identity as (i) Chakradhar Mahato (32 Yrs) S/o- Babulal Mahato (ii) Kalipada @ Kaliya Mahato (32 Yrs) S/o- Nipendranath Mahato both of Vill- Kanali, PS- Purulia (M), Dist- Purulia (iii) Jagadish Ch. Roy (42 Yrs) S/o- Lt. Kanka Roy of Vill- Bamro, PS- Purulia (M), Dist- Purulia & (iv) Arjun Mahato (30 Yrs) S/o- Badal Mahato of Vill+PO- Fusro, PS- Chandankeyari, Dist- Bakaro, Jharkhand. On search Cash of Rs- 37,700/- (Thirty Seven Thousand Seven Hundred) was found in that place. So, I seized (i) Rs- 37,700/- (Thirty Seven Thousand Seven Hundred) of cash (ii) Playing cards 32 pcs (iii) One Charge Bulb (iv) One yellow colored plastic sheet from the possession of the said detained accused persons under proper seizure list duly signed by the accompanying Police forces and accused persons except one accused. The seizure was made between 21:25 & 21:55 hrs.



As the above noted accused persons committed an offence which is punishable U/S- 3/4 of WBG & PC Act. Hence, finding no other alternative way I arrested the above noted accused persons after observing all formalities regarding arrest as they were playing cards within exchange money for wrongful gain or wrongful loss each and others. The whole process of raid, seizure, labeling, arrest, has been videography.

Under the above facts and circumstances, I therefore, pray before you kindly take lawful action against the arrested accused persons namely (i) Chakradhar Mahato (32 Yrs) S/o- Babulal Mahato (ii) Kalipada @ Kaliya Mahato (32 Yrs) S/o- Nipendranath Mahato both of Vill- Kanali, PS- Purulia (M), Dist- Purulia (iii) Jagadish Ch. Roy (42 Yrs) S/o- Lt. Kanka Roy of Vill- Bamro, PS- Purulia (M), Dist- Purulia & (iv) Arjun Mahato (30 Yrs) S/o- Badal Mahato of Vill+PO- Fusro, PS- Chandankeyari, Dist- Bakaro, Jharkhand. 3/4 others and the owner of said shed Birbhadra Gorain of Vill- Bamro under proper section of Law.
