To The Inspector-in-Charge Purulia (T) PS Dist-Purulia

Sub: Prayer for lodging a FIR.

Respected Sir,

With due respect I beg to state that, I LSI, Iti Neogi of Purulia (T) PS do hereby lodge Suo Motu complaint against approx 300 unruly followers of BJP to the effect that today (02.09.2024) at about 13:30 hrs, BJP Party organized a protest rally followed by DM Office Gherao Program regarding recent incident of R.G. Kar Hospital from Jubilee Maidan, Purulia to DM Office, Purulia, without taking any permission from Local Police Station. I was detailed as local supervising officer for lady police deployment at different points around DM Office. At about 13:45 hrs when the aforementioned protest rally of the BJP supporters reached Court More they suddenly started to set an effigy on fire, on the road. As the fire could endanger human lives and other properties, I/C Purulia (T) PS came to the spot alongwith other officers and tried to extinguish the fire; but the supporters prevented police from doing lawful duty, became unruly and got into scuffling with on-duty Police. Hence I/C Purulia (I) PS declared the gathering as unlawful assembly and asked them to disperse, but they didn't pay any heed to the direction. Then having no other way, I/C Purulia (T) PS and other accompanying force and officers pushed them away. Subsequently, the same BJP rally came near DICO Office Purulia and breached the barricade erected for safety and security of DM Office. In the process, the unruly BJP supporters assaulted the on duty police personnel, who were guarding the barricades. Again IC Purulia(T) PS, who was present at the spot declared the gathering as unlawful assembly and asked them to disperse but this time also they didn't pay any heed to the direction. Instead the unruly mob kept on scuffling with police and during the scuffling one police helmet and one body camera were snatched away by the memebers of the unruly mob. Shri Shibnath Paul, I/C, Purulia (T) PS and other police personnel sustained injury due the the assault by the unruly mob. Finding no other option, I/C Purulia (T) PS and other accompanying force and officers pushed them away from the spot.

In view of the above I request you to take appropriate lawful action.
