which are kept concealed in two blue and black big sized sports bags along with the arrested accused Mithun Chakraborty ( 40 ) S/O Sisir Chakraborty of Garikhana, Ambarishpally, Ward No-18, PS- Purulia Town and depicting the fact that today (13/09/2024) at 02:05 hrs during night mobile duty (Out GDE No -741 Dated 12:09:24 ('C' No -2957/24') myself along with C/11 Kajal Mukherjee & C/780 Dileswar Hansda in Govt. Vehicle arrived at Daserbandh More and found one person was moving with two big sized sport bags and seeing police he tried to move faster from the place and started suspicious behavior. When he was asked his name he disclosed his identity as Mithun Chakraborty (40) S/O Sisir Chakraborty of Garikhana, Ambarishpally, Ward No- 18, PS- Purulia Town, Dist-Purulia. But when he was asked the reason for his presence in such an odd hour of night at that place he stated that he is coming from Asansol and going to house. When he was asked when are inside the backpacks, he suddenly tried to flee away leaving the backpacks but police were alert hence could able to apprehended him. After that the person confessed that he along with one Sanjay Singh and some others had committed theft in a mobile shop at Asansol area and he was going to his home with those stolen mobile phones keeping concealed in these tow back pack. He also stated that Sanjay Singh and others have fled away with the other stolen mobile phones which were stolen from the shop. Accordingly I informed to I/C Purulia (T) PS, Dist- Purulia about the fact and as per his kind direction and after abiding by the procedure, those said two bags were searched under videography in presence of the police and public witnesses and to our utter surprise total 42 mobile phones in sealed packets were recovered from the various pockets of these two back packs. These mobile phones were seized under proper seizure list duly signed by the witnesses and under videography as per procedure. After that I arrested the said Mithun Chakraborty under proper arrest memo as he refused to accept the notice u/s 35 BNSS.

Therefore, I pray to you that necessary legal action may kindly be initiated against the arrested accused Mithun Chakraborty (40) S/O Sisir Chakraborty of Garikhana, Ambarishpally, Ward No-18, PS- Purulia Town, Dist-Purulia and one Sanjay Singh and others under proper section of law.
