Myself MRINAL LATH age 28 Yrs' resident
of Durga Gopal Complex, N.C. Das Gupta Road,
Madhya Bazar, Punelea - 723101 today at 20:15
Mrs. Satish Lath C/o Rajesh Kumar Lath came
to my place at 1st floor, Durga Gopal Complex,
threaten me with high voice and assaulted
me with ~~beating~~ ^{Beating} me. As I am also a
witness and co-complaint for the case registered
in the punelea town police station as FIR 51/2024
they threaten me that and assaulted me shortly
that they will kill me today. First Satish
Lath assaulted with ~~first~~ first in my face
and head and after that with his legs on to
my chest. Due to the previous case's grudge
and my involvement they assaulted me
with foul languages and ~~beating~~ beating me today.
Threatening me to take the case back otherwise
I will not be alive. Previously also they
have threaten me for the same but
today assaulted me. I am feeling

concussion and pain in my chest because of today
beating up and my body is shaking because of that..

As I am staying at the same premises
if anything happens to me, the
reason and blame lies with Rajesh kr. Lath,
Harish kr. Lath, Satish Lath as they also
have access and one of them stay at the
same premises. Today's incident has
tortured me and shaken me from
inside and outside mentally too.

As they came to know that My
father never signed family settlement
deed 2004 and they did forging of
documents with my father's signature
to usurp our joint family property for
the same car was also registered
in Purnia town police station case no. 51/24
because of this they threaten and assault
we change my statement and back
off from car.

I beg before you for ~~pro~~ proper
justice and protection.
