Today e.g. 11.09.2024 at about 12:40 PM undersigned along with other WBSEDCL officials namely 1) Sri Suraj Kumbhakar JE (GR-I), Telkalpara CCC, WBSEDCL 2) Sri Deb dulal Banerjee (Lm) , Telkalpara CCC, , WBSEDCL along with other technical personnel of the CCC was on a routine inspection at consumer premises at Chepra, Purulia, When the inspection team found that one person namely Jahagir Sk, S/O Sk Amin has made direct hooking from nearest L.T.O.H line of WBSEDCL by mean of 04 Sq mm aluminium PVC Wire for usage in his Domestic premise which is clear instance of theft of electricity.

I assessed total electrical load of the premises to be 0.24 Kva.

I immediately disconnected the supply and dismantled the said hooking device and seized (approx length 4 mtr as a Sample of hooking device) it and properly sealed and labeled under proper seizure listand left the premise at about 12:50 PM.

Under this circumstances that the accused has committed theft of electricity by way of direct hooking from nearest L.T.O.H line of WBSEDCL distribution system of which being cognizable offenses and is therefore liable for prosecution under section 135(1)(a) of the electricity act 2003 as amended till date, you are therefore requested to take cognizance of the offence and lodge FIR against the accused.
