I. Shashi Bhargava (9830038280), Secretary of Bengal Taekwondo Association complain against Mr. Subroto Banerjee, aged about 59 years, residing at Natabar Sarkar Lane, Purulia Municipality Ward 19,P.O. Namopara, Purulia, District - Purulia, PIN -723103 (W.B.). Sri Subroto Banerjee (reportedly working as Head Clerk, Motor Vehicles Department, Purulia) is running a parallel sports body namely Bengal Taekwondo Association challenging the authority and functioning of the bonafide and registered Bengal Taekwondo Association (same name) having its registered office at 71/1, Canal Circular Road, Kolkata - 700 054 and the latter affiliated to the Bengal Olympic Association and the Taekwondo Federation of India. Bengal Taekwondo Association of which I am the Secretary is affiliated to the Indian Olympic Association and recognized by the Government of India's Ministry of Sports & Youth Affairs and has received grants from the Ministry of Sports, West Bengal. Relevant Certificates evidencing our authenticity and legal standing are enclosed herewith.

On 28.10.2022, Justice (Retd.) Sistani of Delhi High Court in his arbitral award stated that Bengal Taekwondo Association of "Bhargava Group has the original Registration Certificate issued from the office of Registrar of Firms & Societies as well as original PAN Card issued from the date of inception i.e. 1989. Original Minute Books are in their possession and they have filed income tax returns up to date," (currently up to A.Y. 2022-2023). Said Award proves beyond doubt that Bengal Taekwondo Association (of which I am the Secretary) is the recognized and bonafide state body legally authorized and empowered to propagate, popularize, organize and conduct officially the game of Taekwondo in all its forms in the state of West Bengal. In violation of the aforesaid order the fake Bengal Taekwondo Association headed by Sri Subroto Banerjee has illegally opened a bank A/c No.1426101018498 in Canara Bank (S. C. Sen Road, Purulia) in the name of his Bengal Taekwondo Association using our registration number at ROS, also apparently our PAN Card and identity.

Bengal Taekwondo Association, headed by Sri Subroto Banerjee had filed an application praying for Injunction but the same has been rejected by 1st Civil Judge (Junior Division) at Sealdah vide an Order dated 08.07.2024 in Title Suit No.366 0f 2022. Despite that the said Subroto Banerjee, in name of his parallel body / fake Bengal Taekwondo Association organised on 11th Augst'2024 a District Championship under his fake Bengal Taekwondo Association and yet again organized from 16th to 18th August'2024, a State Taekwondo Championship – 2024 in Paschim Medinipur.

Sri Subroto Banerjee's malafide practice of running a parallel body in organizing the game of Taekwondo in West Bengal with criminal intention of making wrongful gain is causing acute chaos and disturbance in the game. When any government department/body sends any Certificate of participation or excellence produced by any candidate for verification to our Bengal Taekwondo Association, we are handicapped and at a loss to process the same.
