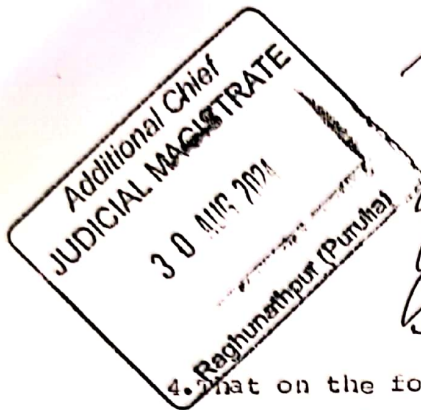

Complainant most respectfully sheweth:-

1. That the complainant is a permanent inhabitant of ward no: 12, Nanduaara ,PS:Raghunathpur, Dist:Purulia having his landed properties within mouza:Nanduaara wherein complainant cultivated paddy in the season after incurring cost of Rs:- 5000/- only.
  2. That on 14-08-24 morning acced. persons infurtherance of their common intention to fulfill their ulterior motive ransho cked the paddy field and damages the seedlings transplanted by the complainant in which complainant raised protest against such illegal and overt act of the acced. persons and as a cons equence a tension was prevailing to that effect.
  3. That on 15-08-24 at relevant point of time acced. persons just to take revenge all the acced. persons having armed with lathy and iron rod i.e. Manik Gorai with lathi and others with rod trespassed in tothe house of the complainant with a view to cause physical injury upon the complainant by giving out threat "KOTHAI GELI BERIYE AI? TOR MATHA NAMIYE DEBO AMADER UPRE URTE SIKHESIS? TOKE KE BACHAI DEKCHI" complainant came out whereupon the acced. person tried to assault the complainant but due to strong intervention of the family members the complainant had narrow escape from the clutches of the acced. persons otherwise acced. could have murdered or caused injury of the comp.it. severely. Acced. persons also gave out threat to the complainant to fake the dire consequence even in exchan -ge of life of the comp.it. if he(comp.it.)dare to cultivate the land anymore.
- As it mentioned hearing screaming local public also came to the spot and seeing them. Acced. left the place of occurrence.

4. That on the following day complainant reported the matter to local police station for taking action against the acced. persons but no action has yet been taken, as such complainant sent his grievance to the S.P. Purulia through Regd. post on 21-08-24, but since that sufficient time has elapsed but no fruitfull result came.

5. That finding no other alternative complainant taking his shelter before the court of law against the acced. persons for committing such crime upon the complt.

It is therefore prayed that necessary direction upon I/C Raghunathpur police Station may kindly be passed giving effect an investigation into the matter after treating the instant petition as an F.I.R. U/S 173 B.N.S.Act.'23.

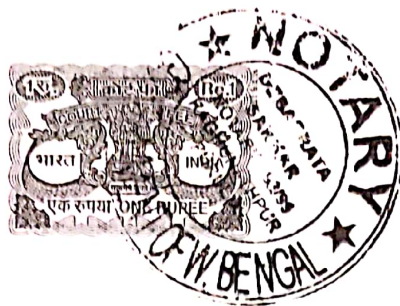
