Sub: Written Complaint for lodging FIR in relation to theft of 5 KVA Single Phase DG set of our Plant.

Respected Sir,

I, Mihir Ranjan Pattanayak s/o Lt. Mahewar Pattanayak, working for gain at M/s Shyam Steel Works Pvt. Ltd., as AGM (HR & IR) company would like to report you about another instance of theft of DG set of our Plant at JSK-II, Lachhmanpur, Raghunathpur, Purulia.

The instance is detailed below:

On 20.09.2024, during the routine round up of the Plant by our Security Personnels at night, one of the security personnel found that a 5KVA Single Phase DG set (Make: Mahindra) of the plant which was kept near the Digardhi Pond was missing. He immediately informed the official in charge at gate about the same. After that a thorough searching of the same was done at the plant but the DG set could not be located. During the said searching, at one place it was seen that the boundary fencing of the plant was cut and dragging mark was found on the ground near the fencing indicating that the DG has been stolen.

Thus, under this circumstances we request you to take this matter under active consideration to find these offenders and to punish them as per law.
