Sub : Prayer for lodging FIR against the arrested accused Kartick Bauri (M/40Y), S/O Lt. Nepal Bauri of Vill. - D-Pabra, PS-Santaldih Dist- Purulia.

Sir,

In producing herewith the arrested accused person named as Kartick Bauri (M/40Y), S/O Lt. Nepal Bauri of Vill. - D-Pabra, PS-Santaldih Dist- Purulia along with seizure - list and seized items as described below, I beg to state that today (13.09.2024) at about 19.05 hrs, while performing evening mobile duty, I received a source information to the effect that the country spirit liquor has been kept at D-Pabra village under this PS in a unnamed shop of above noted accused illegally, with an object to sale. I have informed the matter to I.C. Santaldih PS and this refers to Santaldih PS GDE no. 514, dtd. - 13.09.2024 and as per order of I.C. Santaldih P.S. I along with force left for D-Pabra village to workout the information with the govt. supplied kit box containing white cloth, sealing wax, seal, papers, carbons, match box, candles etc. I had been to the unnamed shop of Kartick Bauri (M/40Y), S/O Lt. Nepal Bauri of Vill. - D-Pabra, PS-Santaldih Dist- Purulia at about 19.35 hours. Seeing police party some unknown persons in front of the said shop were fled away. However, I could detain one (01) among of them and asked about his identity. He disclosed his name and identity as noted above and as well as admitted that he gathered the country spirit liquor for selling. However, I along with said accused started a search inside the said shop and found the following item in the said shop -

- 1) 05 bottles Country Spirit style as Dilkhus each bottle containing 600 ML
From which 01 bottle taken as sample.
- 2) 12 bottles Country Spirit style as Dilkhus each bottle containing 300 ML
From which 01 bottle taken as sample

I interrogated him about the purpose of the stocking and possessing such liquor. He replied it was the business of him. On repeated question he told that the persons who fled away were his customers (names of those not known to him). However he could not show any documents/papers in support of the possession as well as sale of the said articles.

As such, I seized the above items as ALAMAT under proper seizure list with proper videography in between 19.45 hrs and 19.55 hrs & took up (i) One bottle C.S. (Dikhus) 600 ML & (ii) One bottle C.S. (Dilkhus) 300 ML as samples, labeled and sealed accordingly.

Since the allegation against him of possessing, as well as selling the Country Spirit liquor illegally without any valid papers in the unnamed shop has prima-facie been made out and for the interest of proper investigation, I arrested the above accused person at 20.10 hrs accordingly after maintaining all arresting guidelines.

Therefore, I pray before you to start a case under proper section of law against the said accused Kartick Bauri (M/40Y), S/O Lt. Nepal Bauri of Vill. - D-Pabra, PS-Santaldih Dist- Purulia.
