Sub : Prayer for lodging FIR against accd. Jiten Kumbhakar (45 yrs) S/O - Lt. Shantiram Kumbhakar of Aguitard, PS-Santaldih, Dist- Purulia, U/S 46A (c) B.E. Act 1909.

Sir,

In producing herewith arrested accused Jiten Kumbhakar (45 yrs) S/O - Lt. Shantiram Kumbhakar of Aguitard, PS-Santaldih, Dist- Purulia, along with (i) 08 bottles seized country spirit styled as "DIL KHUSH" 600 ml in each bottle, (ii) 13 bottles seized Beer styled as "Kingfisher Strong" 650 ml in each bottle and (iii) 04 bottles seized Rum styled as "McDowell's No- 1" 180 ml in each bottle. I beg to state that during my patrolling duty at Santaldih IC BCW area today i.e on 07.09.2024 at 19.45 hrs acting on a tip off I along with force had been to the shop of Jiten Kumbhakar (45 yrs) S/O - Lt. Shantiram Kumbhakar of Aguitard, PS-Santaldih, Dist- Purulia at BCW bus stand. This refers to Santaldih I/C BCW GDE No- 132 and C.C No- 1447/2024 of dated 07.09.2024. I along with force held raid in the shop of Jiten Kumbhakar at BCW bus stand. Seeing police van some unknown persons coming out from the shop of Jiten Kumbhakar and fled away. However, I could be able to intercept Jiten Kumbhakar. On search found (i) 08 bottles seized country spirit styled as "DIL KHUSH" 600 ml in each bottle, (ii) 13 bottles seized Beer styled as "Kingfisher Strong" 650 ml in each bottle and (iii) 04 bottles seized Rum styled as "McDowell's No- 1" 180 ml in each bottle in his shop. I also found approx 15 empty bottles of country spirit styled as "DIL KHUSH" scattered at the courtyard of his shop. On asked he failed to produce any valid documents in respect of possessing and selling of country spirit and beer in his shop as well as he confessed his guilt. Accordingly, I seized and labeled (i) 08 bottles seized country spirit styled as "DIL KHUSH" 600 ml in each bottle, (ii) 13 bottles seized Beer styled as "Kingfisher Strong" 650 ml in each bottle, (iii) 04 bottles seized Rum styled as "McDowell's No- 1" 180 ml in each bottle under proper seizure list in presence of witnesses duly signed by them. Out of seized bottles 01(One) bottle "DIL KHUSH", 01(One) bottle "Kingfisher Strong" and 01(One) bottle "McDowell's No- 1" are kept as sample.

The Audio & Videography of entire processes of search and seizure has been done. The videography has been stored in compact disk which is enclosed here with.

I also arrested the accd. Jiten Kumbhakar (45 yrs) S/O - Lt. Shantiram Kumbhakar of Aguitard, PS-Santaldih, Dist- Purulia.

However, the accd. Jiten Kumbhakar committed offence U/S 46 A (c) B.E Act, 1909 for possessing and selling of country spirit and beer in his shop without any valid documents.

Therefore, I pray before you that a case may be started against accd. Jiten Kumbhakar (45 yrs) S/O - Lt. Shantiram Kumbhakar of Aguitard, PS-Santaldih, Dist- Purulia under proper section of law.
