Sub : Prayer for lodging FIR against the arrested accused Aklu Mahato (M/60Y), S/O Lt. Ratan Mahato of Vill. - Parasiya, PS-Santaldih Dist- Purulia.

Sir,

In producing herewith the arrested accused person named as Aklu Mahato (M/60Y), S/O Lt. Ratan Mahato of Vill. - Parasiya, PS-Santaldih Dist- Purulia along with seizure - list and seized items as described below, I beg to state that today (22.09.2024) at about 13.35 hrs, while performing day mobile duty, I received a source information to the effect that the country spirit liquor has been kept at Parasiya village under this PS in the house of the above noted accused illegally, with an object to sale. I have informed the matter to I.C. Santaldih PS and this refers to Santaldih PS GDE no. 842, dtd. - 22.09.2024 and as per order of I.C. Santaldih P.S. I along with force left for Parasiya village to workout the information with the govt. supplied kit box containing white cloth, sealing wax, seal, papers, carbons, match box, candles etc. I had been to the house of above noted Aklu Mahato of village Parasiya, P.S. Santaldih at about 14.05 hours. Seeing police party some unknown persons in front of the said house were fled away. However, I could detain one (01) among of them and asked about his identity. He disclosed his name and identity as noted above and as well as admitted that he gathered the country spirit liquor for selling. However, I along with said accused started a search inside the said house and found the following item in the said house -

- 1) 16 bottles Country Spirit style as Dilkhus each bottle containing 600 ML
From which 01 bottle taken as sample.

I interrogated him about the purpose of the stocking and possessing such liquor. He replied it was the business of him. On repeated question he told that the persons who fled away were his customers (names of those not known to him). However he could not show any documents/papers in support of the possession as well as sale of the said articles.

As such, I seized the above items as ALAMAT under proper seizure list with proper videography in between 14.20 hrs and 14.40 hrs & took up one bottle C.S. (Dikhus) 600 ML as sample, labeled and sealed accordingly.

Since the allegation against him of possessing, as well as selling the Country Spirit liquor illegally without any valid papers in his house has prima-facie been made out and for the interest of proper investigation, I arrested the above accused person at 14.45 hrs accordingly after maintaining all arresting guidelines.

Therefore, I pray before you to start a case under proper section of law against the said accused Aklu Mahato (M/60Y), S/O Lt. Ratan Mahato of Vill. - Parasiya, PS-Santaldih Dist- Purulia.
