

## Respected Sir,

I, Parimal Tewary S/O- Lt. Birendra Nath Tewary of Vill- Maliara, PS- Barjora, Dist-Bankura, at present posted at Tamna PS, Dist- Purulia, as ASI of Police producing herewith one arrested accused person namely Srikanta Mudi (38 yrs) S/O- Lt. Khandu Mudi of Vill- Gobindapur, P.S- Tamna, Dist- Purulia with seized articles i.e. 1). One white colour plastic jerican containing approx 09 Ltrs. ID Liquor, 2) 06 pieces plastic glass, 3) One Plastic Bottle containing 1 Ltr. ID liquor as sample which was collected from seized articles Sl No-01 which were seized under proper seizure list.

I beg to submit that today (07.09.2024) during my PS area evening mobile duty received a secret source information that one person is selling LD Liquor at near D-Jungle more near Gobindapur village under Tamna PS, so myself along with i) C/138 Bani Bandopadhyay & ii) C/3006 Prasanta Malla both of Tamna PS came to the spot at about 20:35 hrs and found that one person is selling LD Liquor to the others. Seeing the Police party all customers fled way but we managed to apprehend the accused person namely Srikanta Mudi (38 yrs) S/O- Lt. Khandu Mudi of Vill- Gobindapur, P.S- Tamna, Dist- Purulia. On being asked he failed to produce any valid licence /documents in respect of selling of ID liquor. As such I seized 1). One white colour plastic jerican containing approx 09 Ltrs. ID Liquor, 2) 06 pieces plastic glass, 3) One Plastic Bottle containing 1 Ltr. ID liquor as sample which was collected from seized articles Sl No-01 which were seized under proper seizure list in presence of witnesses and duly signed by them and also arrested the above noted person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labelled in presence of witnesses which was duly videopraphed. I also arranged to inform his family member about his arrest by police.

Under the above fact and circumstances, I therefore pray that a specific case may kindly be start against Srikanta Mudi (38 yrs) S/O- Lt. Khandu Mudi of Vill- Gobindapur, P.S- Tamna, Dist- Purulia as per proper section of law.
